BIOGRAPHIES



Wim MIJS, CEO, European Banking Federation

Wim was appointed Chief Executive of the European Banking Federation in September 2014. Between 2007 and 2014 Wim served as CEO of the Dutch banking association NVB. During this time, he transformed the NVB into a modern industry association, positioning it as the key representative of the banking sector in the midst of the financial crisis. Wim studied law at the University of Leiden in the Netherlands, specialising in European and International law. After his studies, he worked for one year at the International Court of Arbitration at the Peace Palace in The Hague. In 1993, he joined ABN AMRO in Amsterdam before moving to Brussels to head up the bank's EU liaison office. Wim moved back to The Hague in 2002 where he became the Head of Government Affairs for ABN AMRO. Between 2011 and 2015 Wim served as Chairman of the International Banking Federation. From 2012 to 2014 he was Chairman of the Executive Committee of the EBF. From 2013 to 2015 he was President of the Board of Euribor, now known as the European Money Market Institute



Dita CHARANZOVÁ Member of the European Parliament

Dita is a Czech Member of the European Parliament in the ALDE Group. Ms Charanzová completed a doctorate degree from the University of Economics, Prague, and graduated from the Diplomatic Academy in Madrid. She is a former diplomat, whose postings included the Czech Permanent Representation to the EU during the Czech Presidency. She has also worked at the Council of Europe. Ms Charanzová is currently the Vice Chair and ALDE spokesperson of the Internal Market and Consumer Protection Committee and a substitute in the International Trade Committee. Ms Charanzová was named "MEP of the Year" in the field of Foreign Affairs in the 2016 MEP Awards.



Slavka ELEY Head of Supervisory Convergence unit, European Banking Authority

Slavka was appointed Head of the Supervisory Convergence Unit within at the EBA in February 2013. She is responsible for the EBA's work on the common EU supervisory policy and convergence, efficient supervisory cooperation, recovery planning and the early intervention framework. The supervisory policy work includes IT risks and risks related to financial innovation. She chaired different working groups at the EBA as Sub-group on Risk Assessment Systems mandated to develop the common SREP framework. Currently she chairs the Sub-group on Supervisory Effectiveness and Convergence. Prior to joining the EBA Slavka worked for the National Bank of Slovakia where she held a number of roles in supervision and prudential policy. She holds a MBA in general management from the City University of Seattle and a Master degree in Mathematics, Physics and Education from the Comenius University Bratislava.

Lisa RABBE CEO of Stratosphere Advisors LLC

Current projects focus on policy and regulatory issues at the juncture of tech and financial services, including cloud based services, cyber security, data privacy, big data and virtual competition. Ms Rabbe is an advisor to the European Cloud Alliance, an organization dedicated to supporting and promoting successful use of the cloud in Europe. She is currently an instructor on the Oxford Saïd Business School's inaugural FinTech Course. She is a founding member of the RegTech Council, which convenes financial regulators, RegTech start-ups and other stakeholders to facilitate common modes of connectivity between RegTech suppliers and their clients. She cochairs the RegTech Council's infrastructure subcommittee, which is drafting a definition and principles of computational integrity for the RegTech sector. Prior to this, Ms. Rabbe was Managing Director and Head of Public Policy for the Europe, Middle East and Africa (EMEA) region for Credit Suisse, and Managing Director and Head of Government Affairs in the EMEA region for Goldman Sachs International. She began her career at Sullivan & Cromwell in the Corporate Finance practice. She currently serves on the Advisory Board of the Oxford MSc in Law & Finance, and is the industry advisor to its student Fintech society. Ms. Rabbe has also been a member of the Advisory Board of the European Corporate Governance Institute since 2012. She has been recognized by Financial News in its "100 Most Influential Women in Finance" list from 2010-2015. Ms. Rabbe holds a B.A. in Government from Dartmouth College.

Arthur van der WEES Managing Director, Arthur's Legal

Arthur is senior lawyer, technologist, entrepreneur, standardisation expert, investor and frequent speaker worldwide who has in-depth experience and is well connected in the world of technology, finance energy, data & global business. He is co-founder of CloudQuadrants on the maturity of cloud offerings, the Cyberchess Institute that landscapes the real-life cybersecurity arena, the Cyber Trust Institute that sets trust trajectories and orbital requirements and parameters for technology-as-a-service and the Institute for Next Generation Compliance that promotes the restructuring and automation of compliance and related procurement.
